The course offers students knowledge about the current basic conceptual and institutional framework of regional development in Greece, through the systematic presentation and analysis of the organization, operation and financial management framework of local authorities in Greece, so that they acquire the necessary background for further deepening in the individual knowledge fields of regional science, during their studies at the Department of Economic and Regional Development.

Upon completion of the course, students will be able to have:

- be aware of the current institutional and legal framework of regional development in Greece,
- know in practice the "given" ability of the Governments to regulate or "reform" the State, Regional and Local Administration Structures and to determine the corresponding development policies at regional and local level,
- be aware of the possibilities and tools of financial interventions of Regional and Local Structures on their own initiative and responsibility,
- be aware of the experience of previous development laws, the current investment law 4399/2016 (Current regime for private investments, Beneficiaries of aid and conditions of affiliation, Aid provided by the Development Law, Aid schemes of the new Development Law),
- "borrow" best practices from other similar structures of EU Member States and adapt them to the Greek conditions,
- Utilize mechanisms such as Regional Development Funds,
- Utilize the competitive points/advantages of the Operational Plans of Regions and Municipalities,
- understand the concept and role of Strategic Investments, understand the processes and role of Spatial Planning in the "production" of development,
- know about EU Regional Policy and EU Co-funded Programmes,
- know and exploit the possibilities of financing development, through institutional bodies and procedures.

3. COURSE CONTENT

The structure of the course is compatible with the relevant Organizational Chart of Studies of

the Department, enriched with new data, which emerged ex post, with the adoption of the New Law (Kleisthenis Program) and consists of 4 Parts.

Especially:

Part A covers issues of organization of the Central State and its "complementary" System, Local Government, as a necessary condicio sine qua non for the organization and support of development processes.

Part B focuses on Local Government, and discusses issues related to the new institutional functions of Local Government in Greece and the relevant institutional framework and the corresponding frameworks at international and, mainly, European level.

Issues such as the new regulations for Local Government through the institutional framework "Kallikratis II", the newer (proposed) regulations through the "Kleisthenis I" program, the financial tools of local authorities, the specific actions of local authorities, such as those referring to culture, but also the individual regulations on local government in other countries, and the European Charter of Local Autonomy compose the material of Part B.

Part C deals with the specific regulations, policies, instruments, and tools for development and especially the regional development.

Part D (last part) deals with international organisations and the development interventions of the European Union.
